1	Which office is implementing Ranking of States/ UTs for land acquisition projects under RFCTLARR Act
Ans	Department of Land Resources (DoLR), Ministry of Rural Development
2	Under which statute (central Act), the details of Land Acquisition Projects for Ranking of States/ UTs, is being done?
Ans	The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (RFCTLARR Act 2013)
3	Land acquisition projects, starting from which date, are eligible for computing Ranking of States/UTs?
Ans	DoLR has been entrusted with responsibility of ranking of States /UTs on Land Acquisition for projects under the RFCTLARR Act 2013 from 1st January 2014 onwards
4	What is criterion for assigning marks for Ranking of States/ UTs for land acquisition projects?

Ans	Ranking will be automatically determined by software, based on Average marks per projects

8	What data is to be entered reported?

9	What is to be mandatorily mentioned to identify a User's account?
Ans	To identify a user-account, User-ID should be mentioned in all communication.
10	Whom we have to contact for clarification on issues related to registration process?
Ans	At the portal, a 'Contact Us' page is provided and it lists email address and phone numbers of all concerned officials.
11	The projects will be entered at State level or District Level?
Ans	Projects are supposed to be entered / reported by District-level accounts; though data-reporting from State-level account may also be provided on demand.
12	Is it necessary that all the projects are to be entered by a single user?
Ans	No. It is better that all projects of a district are reported by single District-level user-account; but different projects may be divided and assigned to different user-accounts of same district
13	How edit/ correct/ update entries of a project?
Ans	Reported data is, presently, allowed to be updated or corrected as desired by the reporting officer.
14	Whom/ how to request addition of a Project Category or Sub-category?
Ans	If a new or additional Category or Sub-category of project is desired, same may be requested by email.
15	Can multiple user in a district use to enter the data of project in MIS?
Ans	Yes, But there are chances of repletion of the project in MIS.

16	Are mega projects like MGNEREGA included in the Ranking?
Ans	If Land Acquisition is done under RFCTLAAR Act 2013 for the MGNEREGA, it will be included in Ranking.
17	Is there any option to delete or edit project ?
Ans	At present there is no option to delete or edit the project. However to rectify the error request has to made to NIC for further help.
18	Is there the ranking of States/UT are transparent?
Ans	Yes, It is completely transparent and full proof. It is generated automatically through the MIS. No Manual calculation/interface of the Department is involved.
19	Is there any discrimination on the basis of the cost of the projects?
Ans	Cost of the project has no weightage in the present ranking system.
20	If project SIA exempted, How marks are assigned to the project?
Ans	In case project is SIA exempted the marks assigned for SIA are proportionally allocated /added to the marks allocated for filling completion of the pro
